Membership: January 1 - December 31

- ◆ Any member who owes replacement costs for lost or damaged book(s) forfeits all membership privileges until the balance has been paid.
- ◆ Any member who violates the terms of the library's contract with Westlaw or LexisNexis forfeits all membership privileges.
